### 7.1.2 Community Engagement

- o None presented as Michael Donato is absent.
- O Christian Verdicchio opened the discussion about the Central Italy Earthquake appeal. Spoke to SAIA, COASIT and Dante Alighieri to make donations online, fund me page. The money raised will go to the Italian Red Cross.
- Francesco Giacobbe advised against it as there will be fee charges and the funding will not be tax deductable. More favourable to a national fund.
- o COASIT Sydney is a fundraising authority for the Earthquake Appeal and can issue tax deductable receipts and there are no fees involved. A coordinating committee

has been established. A separate bank account has been organised, with 2 board directors and signatories.

- o Francesco Giacobbe rose that after the experience with the Abruzzo earthquake 7 years ago, suggested not to be in a rush, look into a project that is achievable and needed e.g. helping with the items/furniture for the school, have clear objective.
- For the Abruzzi earthquake \$2milion were raised plus matching funds from the Federal Government to reconstruct the Opera Theatre. The money raised is still in the bank account in Australia as the project to reconstruct got approved only recently.
- Multimedia groups are also organising radiothons, newspapers (Il Globo, La Fiamma) are promoting an appeal for donations.
- Alessandro Vecchiarelli raised concerns about the fund web page, not everybody understands the process of it and will lose a lot of people; there is a tendency to rush to raise money, more important to target a specific target.

Action: all members to think about the options of: 1- Fund me page; 2 – National fund with own bank account e.g. Com.It.Es. or SAIA; through COASIT Sydney. All to put forward thoughts and then a document will be circulated: Mark Quaglia, Martina Matta, Christian Verdicchio and Alessandro Vecchiarelli.

The meeting was interrupted at 7.15pm for the scheduled meeting with the Veneto Club.

#### Com. It. Es. meeting resumed at 8.15pm

- 7.1.3 Education and Research Angela Scarino
- O Project submitted and tabled. Database of Italian Scientific and Research Expertise in South Australia, a project in collaboration with ARIA to establish a register of Italian academics experts. The data base will capture the work of Italians to be able to present a picture of expertise and with a valuable story to tell to the Australian community how the Italians have contributed to the

### 10. Sen. Francesco Giacobbe Report

Reported on:

- Visit from INPS officials in Adelaide ask relevant questions, make them commit
  to important issue; at the Melbourne meeting with the 'Patronati' was discussed
  about the Australian legislation, age pension and the pension rate when outside
  Australia. As Italian parliamentarian cannot interfere with Australian legislation.
- Lack of a lobbying group in the Italian community to put forward any concerning issues. Need to have local parliamentarian to lobby and those working in the field.
- ARIA has been one of his focal activities.
- Italian Language funding budget approved for next year, there will be an
  assessment and then it will need to final approval. Important to work on
  reasonable projects to get funding.

- Working Holiday Visa a lot of young Italians don't know that they can claim unemployment once they return to Italy.
- Has been working hard on trading exchange Italy-Australia; looking at special visa for companies and investors for exchange businesses;
- Italian Chamber of Commerce. Not existing in Adelaide however the ICCI in
  Sydney will be happy to have a branch. Outlined that the ICCI abroad are managed
  different from the one in Italy, if the ICCI abroad don't invent themselves and start
  cooperating will not get anywhere, they are however a good point for network.
- Enti Gestori funding 2017 additional funding has been approved.
- Com.It.Es. and CGIE reform Com.It.Es. needs to be reinforced, have a role to be
  able to liaise directly to the authority. CGIE, it has become nearly no-existing.

Sen. Giacobbe thanked for including him in the meeting and congratulated the members for their work.
